GCSO LAW ENFORCEMENT SUMMARY

JANUARY 9, 2016 – JANUARY 15, 2017

On Monday, January 9, 2017, Deputy C. Sanders executed a transport order and transported Jarrett Cleveland Pridgeon (35) and Rodney Dewayne Johnson (39) to the Gulf County Detention Facility (GCDF).
