## **GCSO LAW ENFORCEMENT SUMMARY**

FEBRUARY 12, 2018 – FEBRUARY 18, 2018

On Monday, February 12<sup>th</sup>, Sgt. J. Murnan was dispatched to the 1300 block of Indian Pass Road to investigate a residential burglary. It was reported that an intruder had entered into a home by breaking through a kitchen window. The intruder only stole a bottle whiskey, a bottle of scotch and beer from the refrigerator. A suspect has been developed based on motive and location similarities. Items were collected at the scene and lab analysis will be conducted to determine if the items contain any evidentiary value.

On Monday, February 12<sup>th</sup>, Sgt. J. Williams and Deputy A. White responded to the 200 block of Ponderosa Pines Drive in reference to a report of a physical altercation. It was learned that the disturbance was of a domestic nature, in which Michelle Elizabeth Davis (49) was found to be the aggressor. Davis was placed under arrest and transported to the Gulf County Detention Facility, where she was charged with Domestic Battery.

On Wednesday, February 14<sup>th</sup>, Deputy L. Greenwood was dispatched to the 200 block of Annie Avenue to investigate a report of a suspicious person. It was reported that a man named Ryan Carver was seen running through the neighborhood and attempted to gain entry into a travel trailer. Carver then ran to a waiting car and the car drove away. Investigators S. Ferrell and P. Williams assisted Deputy Greenwood and positively identified Ryan Michael Carver (26) as the suspect. As a result of the investigation, Carver was located and placed under arrest for Attempted Burglary.

On Thursday, February 15<sup>th</sup>, Deputy M. Manley was dispatched to investigate a report of a disturbance on Armstrong Road in Wewahitchka. According to witnesses, Deputy Manley learned that an unknown white male drove up to a house on Armstrong Road, exited his vehicle, pulled down his pants and defecated at the end of a resident's driveway. Additionally, the man urinated on the trash can and drove away. A suspect was identified and charges are pending against the man for Disorderly Conduct.

On Thursday, February 15<sup>th</sup>, Keith Lanier Hanley (52) was arrested at the Gulf County Detention Facility on a Violation of Probation warrant. Hanley was on probation for Burglary (x4) and Grand Theft (x2). Hanley was already incarcerated on unrelated charges.

On Friday, February 16<sup>th</sup>, Deputy D. Sanders was dispatched to Roberts Cemetery Road in reference to a burglary. It was reported that someone had forced their way into a residence and rummaged throughout the home. Nothing was reported missing.

On Saturday, February 17<sup>th</sup>, Deputy D. House and C. Harvey were investigating the whereabouts of Timothy Ryan Clark (43), for the purpose placing him under arrest on a Violation of Probation warrant. Clark was on probation for Uttering Forged Bills and Trafficking in Stolen Property. The deputies located Clark at the Dixie Bell Motel, where he was taken into custody and transported to the Gulf County Detention Facility.

On Sunday, February 18<sup>th</sup>, Deputy A. White was assigned to investigate a report of counterfeit bills being past at the Dollar General in Wewahitchka. Deputy White met with store employees and verified that a counterfeit \$100 bill was used. Deputy White was able to locate the person who passed the bill and a second counterfeit \$100 bill was recovered from that person. The subject he recovered the bill from denied any knowledge of the bills being counterfeit. No criminal charges are pending at this time. We do ask that businesses pay extra attention to currency they are taking in, in case there are more counterfeit bills circulating.

On Sunday, February 18<sup>th</sup>, Deputy D. House responded to a verbal disturbance at the Creek Stop Deli in Wewahitchka. Reports had indicated an intoxicated patron was in the store, trying to start fights with other patrons and making rude comments toward the clerk. Deputy House arrived on scene and identified the suspect as Charley Dean White (52). White had been drinking alcohol and also admitted to taking Xanax. White was placed under arrest and charged with Disorderly Intoxication.
