## **GCSO LAW ENFORCEMENT SUMMARY**

JULY 30, 2018 - AUGUST 5, 2018

On Monday, July 30<sup>th</sup>, Deputy D. House arrested Savanah Kaye Shiver (23) on Whiting Street in Highland View on a Franklin County arrest warrant.

On Monday, July 30<sup>th</sup>, Investigators P. Williams and S. Ferrell conducted a traffic stop on Hwy 71 near the intersection of Long Ave. The driver was identified as Michael Shawn Meyers (31). While running a driver's license status check on Meyers, it was revealed that there was an active warrant for his arrest out of Alabama for failing to return rental property. Meyers was placed under arrest and transported to the Gulf County Detention Facility to await extradition.

On Wednesday, August 1<sup>st</sup>, Deputy M. Manley was dispatched to a residence on West Avenue in Burgess Creek in reference to a disturbance. During a verbal altercation, William Harley Brown (23) became aggressive and damaged a television set inside the home. He also damaged an air conditioning unit outside the home. Brown was placed under arrest for criminal mischief and transported to the Gulf County Detention Facility.

On Wednesday, August 1<sup>st</sup>, Deputy J. Page arrested Kimberly Ann Clarkson (35) at the Gulf County Sheriff's Office on a warrant for violation of an injunction for protection against stalking. The warrant stemmed from an incident that was reported to Deputy D. House on July 27th, 2018.

On Wednesday, August 1<sup>st</sup>, Nathan Patrick Benore (27) was transported to the Gulf County Detention Facility by a prisoner transport service out of Lee County, Florida. Benore was wanted on two warrants for Sexual Battery and Burglary involving a Battery. The charges against Benore resulted from an incident that occurred on July 15, 2018, in Howard Creek. Benore fled the area when he learned of the investigation against him but he would be apprehended in Ft. Myers, Florida, after warrants for his arrest were obtained.

On Thursday, August 2<sup>nd</sup>, Deputy J. Page was dispatched to Seacliff Drive on Cape San Blas in reference to a burglary. It was discovered that several television sets and some miscellaneous bedding was missing from the residence. If anyone has any information regarding this burglary please contact the Gulf County Sheriff's Office.

On Friday, August 3<sup>rd</sup>, K-9 Deputy M. Peek conducted a traffic stop on a vehicle at the intersection of Monument Avenue and 10<sup>th</sup> Street in Port St. Joe. During the course of the traffic stop Deputy Peek deployed K-9 Brix on the vehicle. Brix alerted on the vehicle, indicating the presence of narcotics. A probable cause search of the vehicle ensued which revealed methamphetamine and syringes. It was determined that the contraband belonged to the passenger, who was identified as Cresta Denise Morrison (41). Morrison placed under arrest and charged with Possession of Methamphetamine and Possession of Drug Paraphernalia.

On Friday, August 3<sup>rd</sup>, Deputy G. Desrosier travelled to Violet Pippen Road to assist Probation and Parole with the arrest of Theodore Dwayne Kennell (20) on a warrant for Violation of Probation. Kennell was apprehended and transported to the Gulf County Detention Facility without incident.

On Saturday, August 4<sup>th</sup>, Deputy C. Harvey was dispatched to Hartley Lane in reference to a theft. The complainant reported that four chairs and two umbrellas were taken from the beach. The chairs were described as light blue in color with the logo "VAYK GEAR" imprinted on the chairs. Please contact the Gulf County Sheriff's Office with any information regarding the theft.

On Sunday, August 5<sup>th</sup>, two theft reports were called in from the 9000 block of W. Hwy 98 in St. Joe Beach. Deputy S. House responded to the first complainant stating that a fishing cart was stolen from the back porch of a residence. The second complainant stated that a tent was taken from the beach. If you have any information regarding these thefts, please contact the Gulf County Sheriff's Office.

On Sunday, August 5<sup>th</sup>, the Gulf County Sheriff's Office arrested James R. Jackson (44) at the Gulf Correctional Institute after he was released from state custody. Jackson was wanted out of Houston County, Georgia. Jackson was transported to the Gulf County Detention Facility to be held for extradition.

On Sunday, August 5<sup>th</sup>, Deputy S. House was dispatched to Treasure Drive in reference to a burglary. Someone had forced their way in to the home, through the garage door, and took an Ozark ice chest while the residents were out of town.
