## **GCSO LAW ENFORCEMENT SUMMARY**

SEPTEMBER 22, 2019 – SEPTEMBER 29, 2019

On Monday, September 23, Chad Edward Medley (38) was served with an arrest warrant at the Gulf County Detention Facility for Violation of Probation. Medley was probation for Possession of a Controlled Substance.

On Tuesday, September 24, Piper Davidson Fleming (55) was arrested in Bay County on a Gulf County warrant. The warrant was issued for Flemings arrest in February of 2019 following an investigation by Deputy J. Page where Fleming allegedly caused damage to a residence she was evicted from.

On Tuesday, September 24, Deputy D. Goodman stopped a vehicle on Hwy 22 in Wewahitchka for not having operable tail lights. The driver of the vehicle was identified as Scotty Lydell Messer (53). During a license check, Deputy Goodman learned that Messer had a suspended driver's license for failure to maintain financial responsibilities. Messer was placed under arrest and charged accordingly.

On Tuesday, September 24, Investigators C. Harvey and S. Ferrell executed an arrest warrant on Starfish Avenue in Beacon Hill by arresting Bradley Hunter Moore (44). Moore was wanted for Battery following a domestic disturbance reported to the GCSO on June 26, 2019. Moore was transported to the Gulf County Detention Facility.

On Tuesday, September 24, Deputy S. Alday responded to a report of a physical disturbance on Amy Circle in Wewahitchka. As a result of Deputy Alday's investigation, Blake Edward Harrelson (23) was placed under arrest and charged with Domestic Battery and Aggravated Assault with a Deadly Weapon.

On Tuesday, September 24, Sherry Ann Robinson (52) turned herself in to the Gulf County Detention Facility on a Violation of Probation warrant. Robinson was on probation for felony DWLSR.

On Wednesday, September 25, Deputy S. Alday conducted a traffic stop on Hwy 71 near the intersection of Bodie Lister Road. The driver of the vehicle, Steven Edward Arthur (48), was found to have a suspended driver's license. Arthur was placed under arrest and charged with Driving While License Suspended/Revoked.

On Friday, September 27, Sgt. P. Williams responded to a report of a domestic disturbance on Blossom Hill Road in Howard Creek. Sgt. Williams encountered a female victim who had some minor injuries. The female had been in a physical altercation with Christopher Andrew Lee (33). Lee was located and charged with Felony Battery.
